

Distribution of COVID-19 Vaccinations

Stoddard Baptist Global Care (SBGC), along with Stoddard Baptist Nursing Home, has implemented the necessary procedures for distributing the COVID-19 Vaccination to residents, staff, as well as board members, per their request. SBGC began the distribution of the vaccination on February 2, 2021 as a partner with Walgreens to deliver and assist with vaccinating residents and staff.

For residents, consent for the COVID-19 Vaccine was obtained from residents that can make their own decisions, as well as from their responsible parties. These residents got the first dose of Moderna on February 2, 2021 and 2nd dose on March 2, 2021. Walgreens staff came once again on April 7, 2021 to give the second dose of Moderna to those that received their first dose on March 2nd.

For staff, department heads obtained consent from several employees that were interested in the vaccine, prior to Walgreens initial visit, to ensure that there were enough vaccines for everyone. Employees signed consent forms, received the vaccine and were provided 15 minutes of monitoring time to ensure that there were no adverse effects.

Exemptions for the vaccination included residents and staff that were in quarantine, had received ANY vaccines within 30 days prior to the vaccination date and had allergies to the vaccine. Along with the vaccinations, Stoddard's facilities continue to adhere to the required safety measures of wearing face masks and maintaining the proper social distancing.

Stoddard's board members, staff and residents also celebrated the installation of the Honorable Kamala Harris as our first Woman Vice President of the United States of America!





The Marigold - Distribution of COVID-19 Vaccinations

The Marigold Assisted Living on 11th Street began their implementation of the COVID-19 Vaccination program on February 3, 2021. All required steps were taken with Walgreens who sent their staff to administer the vaccines to residents and staff. The Vaccination Clinic was set up with coffee, donuts, juice and water, as well as balloons and signage directing the process. The Moderna Vaccine was administered on February 3rd, March 3rd and March 31st. The Johnson and Johnson Vaccine was also administered on the 31st of March. Each recipient received the appropriate documentation indicating they had received the vaccine, as well as a pin that could be attached to their clothing letting others know they had been vaccinated. At the conclusion of the clinic, 100% of the Residents had received the vaccine and almost 90% of the staff had been vaccinated.
